- Contracts cannot be reassigned or transferred. Subletting all or part of your space is not permitted.
- Violation of this rule will void your contract and result in immediate removal from the premises with no refund.
- Sponsor will not be responsible for vendor's property.
- Vendor assumes liability for accidents that occur as a result of negligence on their part.
- Set up hours begin at 7 AM on day of festival. Vendor must be set up at least 30 minutes before festival opens.
- Vendor will supply his/her own tables and chairs. Tents or canopies are recommended in case of rain.
- Vendor will receive one parking pass per booth space.
